To: South Central Public Health and fellow Idahoans:

At 1:00 pm tomorrow, the South Central Public Health officials will meet to consider issuing a Public Health Order for mandatory face coverings in all public places and providing penalties for violation of the order. In the WHEREAS clauses of the order, the following is cited:

WHEREAS, on January 30, 2020, the **International Health Regulations Emergency Committee** of the World Health Organization declared the outbreak of COVID-19 a public health emergency of international concern;

WHEREAS, on March 13, 2020, Idaho Governor Brad Little signed a declaration of emergency for the State of Idaho in response to concerns that cases of COVID-19 are imminent in Idaho

WHEREAS, on March 25, 2020, Idaho Governor Brad Little issued a proclamation declaring a state of emergency for the State of Idaho due to incidences of community spread, increasing occurrence, and the threat to public health and safety arising from the effects of COVID-19,

There is a sequence problem that serves as a giant red flag. They tripped the international law trigger before an actual health emergency was declared by the health community. Dr. Tedros, Director of the World Health Organization didn't declare the health emergency until March 11, 2020<sup>1</sup>

Governor Little declared the state of emergency for Idaho on March 13, 2020 but the problem with that is that there were no cases of COVID in Idaho at the time. Miraculously one case showed up after the emergency was declared. According to US News & World Reports<sup>2</sup>:

*"The news came several hours after Little declared a state of emergency."*

What are the odds?

The Public Health District cites Title 39-414 as giving them the authority by delegation of the State Department of Health and Welfare OR the Director of the Department of Environmental Quality. Presumably their authority derives from Governor Little's declaration of emergency. Attention should be given to the fact that Governor Little cannot delegate authority that he does not have and by the same token, the state's Departments of Health and Human Services and Environmental Quality cannot delegate power they don't have.

The problem as I see it is that the Public Health Districts are not part of the state according to Title 30, 401. They are something nebulous called a "governmental entity" that does not fit within the framework of a republican form of government.

Idaho Constitution:

*Article 1, SECTION 2. POLITICAL POWER INHERENT IN THE PEOPLE. All political power is inherent in the people. Government is instituted for their equal protection and benefit, and they have the right to alter, reform or abolish the same whenever they may deem it necessary; and no special privileges or immunities shall ever be granted that may not be altered, revoked, or repealed by the legislature.*

The Public Health Districts are not accountable to the people. There is serious question whether or not government authority over the people can be delegated to entities that are not accountable to the people.

There are also serious question about the declaration of an emergency. This alleged emergency has gone on for 9 months. How long is an emergency? When does the emergency end? I am reminded that Hitler took over Germany based on the declaration of an emergency while the Reichstag was still smoldering, February 28, 1933 when President Hindenburg signed the emergency decree<sup>3</sup>. The result of that is in the history books including the Nuremberg Trials that followed the end of World War II.

The order to wear a face mask is not a benign order. You would be ordering people to restrict their intake of fresh air – ordering them to breathe the dirty air that they just exhaled. Inside the mask, a warm moist environment is created that is inherently unhealthy. Your order would put healthy people at greater risk through the unhealthy order of the mask and it doesn't take a medical degree to figure that out.

I read recently that the HHS and/or the CDC was planning to meet the day after September 11, 2001 to discuss pandemic planning. That would make the bombing of the World Trade Center towers the parallel in history to the Reichstag Fire. In 2002, the Department of Homeland Security was established but it wasn't an idea that came after 9-11. There were three commissions on terrorism preceding 9-11: the Hart-Rudman Commission, the Gilmore Commission and the National Commission on Terrorism (Bremer Commission). I've been following the pandemic dialectic since 2005 when President George W. Bush announced the National Strategy for Pandemic Influenza<sup>4</sup>. The concept of a pandemic is being used for a political agenda of global governance which brings me back to the first point I made in this letter: the sequence problem of the international health law committee declaring the emergency before the health community declared the emergency. That is not a minor detail is the big picture of things.

The purpose for my telling you that is to let you know that I'm not just a casual observer of events. I'm deeply invested in tracking and documenting the activities internationally, nationally and at our state and local levels connected to the concept of "pandemic" and terrorism in connection with global governance and the attempt to extinguish the nation-state as it is defined under the Westphalian System. The question for you to answer today is which side of the line do you stand on? One side is the American side – sovereign and free nation with independent people. The other side of the line is global governance under a totalitarian system of socialism. As Reagan said, it's a time for choosing.
