Enclosed please find a Summons and Complaints filed by Bonnie Menth and Vicky Davis against Idaho Power Company. The two complaints have been consolidated into one complaint case, IPC-E-12-04. Additionally, the Commission requests information on the cost of: (1) uninstalling a meter and reinstalling a different meter; (2) not being able to remotely gather usage data for billing purposes; (3) offering customers an "opt-out" alternative, and (4) if an "opt-out" alternative were available, the cost of using estimated and actual meter readings to calculate bills.
